### **CURFEW FOR JUVENILES**

Ordinance 182(4)	Juvenile under age of 18 in public place between 11:00 PM to 6:00AM	Penalty: \$50-\$300/5 days
Ordinance 182(6)	Parent, guardian permit juvenile to remain in public between the hours of 11:00 PM to 6:00 AM	Penalty: \$50-\$300/5 days

### **ESTABLISHMENT OF FIRE LANES**

Ordinance 187(2)	Park or permit parking in designated fire lanes	Penalty: \$300/5 days

### **ESTABLISHMENTS PERMITTED TO SERVE ALCOHOLIC BEVERAGES**

Ordinance 159(I)	Enter or remain in establishment licensed by PLCB after hours	Penalty: \$300/30 days
Ordinance 159(II)	Owner, proprietor, responsible person not to permit after hours sales	Penalty: \$300/30 days
Ordinance 159(III)	Steward, manager, bartender or other person not to sell after hours	Penalty: \$300/30 days
Ordinance 159(V)	Enter, remain on the premises to consume alcoholic beverages more than one-half hours after latest time when it can be sold	Penalty: \$300/30 days
Ordinance 159(VI)	Loiter or remain outside the premises after hours	Penalty: \$300/30 days

### **BURNING ORDINANCE 206**

Section	5 A	Within 20 ft of property line or building	Penalty: \$25-\$500/10 days
Section	5 B	10 foot Safety area	Penalty: \$25-\$500/10 days
Section	5 C	Adequate extinguishers present	Penalty: \$25-\$500/10 days
Section	5 D	Sober and capable adult supervision	Penalty: \$25-\$500/10 days
Section	5 E	Permit required between sunset and sunrise	Penalty: \$25-\$500/10 days
Section	5 F	Permit for uncontained fire required	Penalty: \$25-\$500/10 days
Section	6 A	Non-designated area without appropriate container	Penalty: \$25-\$500/10 days
Section	6 B	Unauthorized materials, ie; garbage, household waste, tires, batteries Construction or demo waste, toxic/hazardous chemicals, explosive Materials, non-combustible materials, recyclables	Penalty: \$25-\$500/10 days
Section	6 C	Non-designated area- road right of way or ditch	Penalty: \$25-\$500/10 days
Section	6 D	Failure to extinguish upon authorized order	Penalty: \$25-\$500/10 days
Section	6 E	Burning during hazardous conditions or during burn ban	Penalty: \$25-\$500/10 days

### **SADS BURY TOWNSHIP DOG ORDINANCE**

( 2<sup>rd</sup> or subsequent offense \$300 fine plus costs.)

Ordinance 200(III)(A)(i)	Permit, cause or own dog or dogs that molested passersby or passing vehicles	Penalty: \$25-\$300/90days
Ordinance 200(III)(A)(ii)	Permit, cause, own or was in control of any dog or dogs that attacked other animals or persons	Penalty: \$25-\$300/90days

## **SADSBURY TOWNSHIP DOG ORDINANCE ( Cont'd)**

Ordinance 200(III)(A)(iii)	Permit, cause, own or in control of any dog or dogs repeatedly not under restraint	Penalty: \$25-\$300/90days
Ordinance 200(III)(A)(iv)	Permit, cause, own or in control of any dog or dogs that damage public or private property	Penalty: \$25-\$300/90days
Ordinance 200(III)(A)(v)	Permit, cause, own or in control of any dog or dogs that bark, cry, whine or howl in an excessive, continuous or untimely fashion	Penalty: \$25-\$300/90days
Ordinance 200(III)(B)	Permit, cause, own or in control of any dog or dogs that subject others to offensive odors	Penalty: \$25-\$300/90days
Ordinance 200 (IV)(A)	Fail to keep a dog or dogs under restraint at all times	Penalty: \$25-\$300/90days
Ordinance 200(IV)(B)	Fail to exercise proper care and control of a dog	Penalty: \$25-\$300/90days
Ordinance 200(IV)(C)	Fail to confine any female dog in heat in a building or secure enclosure in such a manner that such female dog cannot contact another dog except for planned breeding	Penalty: \$25-\$300/90days
Ordinance 200(V)(A)	Fail to provide sufficient good wholesome food and water, proper shelter and/or protection from the weather, veterinary care when needed to prevent suffering	Penalty: \$25-\$300/90days
Ordinance 200(V)(B)	Abandon or attempt to abandon any dog	Penalty: \$25-\$300/90days
Ordinance 200(V)(C)	As the operator of a motor vehicle, striking a dog shall stop and render assistance and shall immediately report such injury or death to the dog's owner and/or Conneaut Lake Regional Police Dept or Crawford County Humane Society	Penalty: \$25-\$300/90days
Ordinance 167(V)(D)	Place any poison or harmful substance in any place where it may be consumed by dogs	Penalty: \$25-\$300/90days
Ordinance 200(V)(E)	Confine a dog to any motor vehicle without adequate ventilation and temperature control	Penalty: \$25-\$300/90days
Ordinance 200(VI)	Fail to remove all excreta deposited by dog upon any property other than his own	Penalty: \$25-\$300/90days
Ordinance 200(VII)	Permit vicious dog to be outside proper enclosure unless muzzled and restrained	Penalty: \$25-\$300/90days
Ordinance 200(VII)(A)(i)	The dog has inflicted severe injury on a human being without provocation on public or private property	Penalty: \$25-\$300/90days
Ordinance 200(VII)(A)(ii)	The dog has killed or inflicted severe injury on a domestic animal without provocation while off owner's property	Penalty: \$25-\$300/90days
Ordinance 200(VII)(A)(iii)	Dog has attacked a human being without provocation	Penalty: \$25-\$300/90days
